

**BOROUGH OF EMERSON - COUNTY OF BERGEN  
ORDINANCE 1706-25**

**AN ORDINANCE TO AMEND CHAPTER 200 OF THE CODE OF THE BOROUGH OF EMERSON ENTITLED *PARKS, PLAYGROUNDS AND RECREATION AREAS***

**BE IT ORDAINED** that Chapter 200 of the Code of the Borough of Emerson entitled Parks, Playgrounds and Recreation Areas is amended as follows:

**§ 200-55 Recreational activities and summer recreation camp fees.**

(a)

(b) The fees are approved for the 2025 season only. Thereafter, the fees shall be set annually by resolution of the Governing Body.

(c) No refunds shall be given.

**Article VIII Use of Tennis/Pickleball Courts located at Emerson Jr./Sr. High School**

**§ 200-57 Requirements.**

Registration with and payment of an annual fee, as set forth in § 200-55, to the Borough of Emerson are required for seasonal use of the tennis and pickleball courts located at the Emerson Jr./Sr. High School.

**§ 200-58 Definitions.**

**Season.** April 1 through November 1 of each year, weather-permitting. Season dates are subject to adjustment and courts are subject to be opened and/or closed at the discretion of the Borough of Emerson or the Emerson Board of Education.

**Court Hours.** The times that the courts are open for play to registered participants during the season will be set annually by resolution of the Governing Body with consent of the Emerson Board of Education.

**§ 200-58 Rules and Regulations.**

The Rules and Regulations for use of the tennis and pickleball courts located at the Emerson Jr./Sr. High School shall be adopted annually by resolution of the Governing Body and shall be posted on the borough website and available to the public in the Clerk's Office.

Except as modified herein, all other provisions of Chapter 200 shall remain in full force and effect as previously adopted.

This ordinance shall take effect immediately upon final passage and publication as required by law.


