## ORDINANCE NO. 1720-26

### AN ORDINANCE AMENDING AND FIXING THE SALARY RANGES OF THE EMPLOYEES OF THE BOROUGH OF EMERSON

**BE IT ORDAINED** by the Mayor and Council of the Borough of Emerson, County of Bergen, State of New Jersey, as follows:

**Section I.** Salaries, wages and compensation for the following employees for the calendar year 2025 are hereby fixed and the same shall be as follows per annum, except where otherwise stated. If the compensation noted does not have a range listed, then that number is the maximum compensation for that position.
